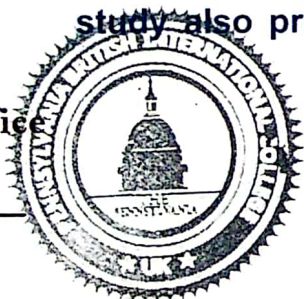
Summary Of The Study

This thesis aims to model and evaluate financial risks and crises in emerging financial markets, with a focus on providing a comparative analysis between several markets. The study covers financial markets in countries such as Brazil, India, China, and South Africa, and seeks to understand how various economic and political factors affect the stability of these markets.

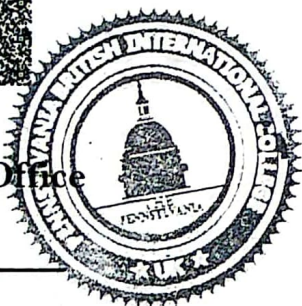
